Forms **must be given** to the species superintendents on entry day to check identification after animals are unloaded and placed in the barns. The Fair Superintendent will verify all tags. The County Fair Vet will visually inspect exhibits and examine required paperwork.

Attach copies of the vet inspection certificates and/or test papers as they must be kept on file at the Richland County Fair Secretary’s Office per Department of Agriculture, Trade & Consumer Protection (DATCP) rules and regulations. Certificate copies will not be returned to exhibitors. SHEEP/GOAT Exhibitors must provide full scrapie number! ALL SWINE must have the full 840 number. Examples of Identification on back.

If exhibiting one species, for example, Beef (Dept. 102), only one form is required.

If exhibiting more than one species – a separate form for each species is required. Examples:

- If you are exhibiting both Beef (Dept. 102) and Poultry (Dept. 107), two forms are required; one for each species.
- If you are exhibiting both Dairy (Dept. 101) and Beef (Dept. 102), two forms are required; one for each species.

If more than one family member is exhibiting, all animals of the same species may be listed on one form. An additional form is needed for each species that will be exhibited.

- *If a family has two youth showing Sheep (Dept. 104), all of the animals can be listed on the same form/family.*
- *If a family has two youth and one is showing Poultry (Dept. 107) and the other is showing Dairy (Dept. 101), they will need to fill out two forms.*
